

Core Teaching Assistant - Job Description

Department: Mailman School of Public Health – The Office of Educational Programs

Job Duration: Fall 2018 semester (grading duties might continue into January 2019)

Hours per week: Varies depending on the studio (ranges from 6-15 hours per week)

<u>Note:</u> Per University policy, students can only work for a combined maximum of 20 hours per week across all Columbia positions at any one time.

Salary: Varies depending on the studio (ranges from \$2,000 - \$4,600)

Job Summary: Reporting to the Studio Lead Teaching Assistants, a Teaching Assistant will support the studio's educational goals by fulfilling a range of educational and logistical responsibilities.

Teaching Assistant Responsibilities include:

- Meet weekly with Studio Lead Teaching Assistants
- Grade student assessments by predetermined deadlines
- Facilitate discussion or lab sections (depending on studio specific needs)
- Pre-test and proctor assessments (depending on studio specific needs)
- Hold a minimum of one office hour a week during the semester.
- Meet with students when necessary
- Provide technical support during lectures and stay up to date on studio content
- Implement a code of confidentiality when overseeing sensitive academic content
- Respond to student inquiries via email and follow-up in a timely manner
- Maintain communication with Studio Lead Teaching Assistants, Studio Faculty, OEP, and students

Teaching Assistant Responsibility Breakdown:

(percentages are approximate and are variable across studios)

•	Grading and responding to student grading inquiries	45%
	Assessment logistics, classroom support, and weekly meetings	
•	Responding to miscellaneous student inquiries or concerns	15%
•	Facilitating discussion or lab sections	15%
•	Weekly office hours	5%

Qualifications:

- Completion of the Core curriculum
- Professional, patient, respectful, and mature character
- Excellent oral and written communication skills
- High level of organization and emotional intelligence
- Experience using discretion when privy to high level discussions
- Demonstrate ability to understand studio content and verbalize concepts to students

Preferred Qualifications:

- Prior teaching experience
- Prior schooling in the studio topic areas outside of the Core curriculum
